


### Investment proposition

It generally contains 50–80 stocks, and positions at initiation are typically 1–3 per cent of the portfolio. We seek to ensure a high degree of diversification, with no stock representing more than 5 per cent of the portfolio at the time of purchase.


#### Indexed to 31 December 2025
