As described in the glossary, transaction costs have been calculated using the 'slippage cost' methodology which is the difference between the executed price of the trade and the mid-price of the trade when the order to transact was transmitted to a third-party.

The total charges deducted throughout your investment will have an impact on the return you might get. While performance cannot be guaranteed, we have given an example of how the charges will affect what you might get back and the illustration below shows you the effect charges have when comparing the return before and after fees.

For the purpose of this illustration, we have assumed a growth rate of 4.5% and ongoing charges and transaction costs being deducted monthly throughout the life of your investment. In practice ongoing charges are accounted for by a daily accrual in the fund.

### Glossary

<b>Charges Type</b>	<b>Description</b>
<b>One-off charges</b>	Costs and charges (included in the price or in addition to the price) paid at the beginning or at the end of the investment in the fund. These include distribution fees and any front-loaded management fee.
<b>Ongoing charges</b>	Costs and charges relating to the management of the fund that are deducted from the value of the fund. These include the management fee and payments made to parties providing services to the fund other than the manager such as, but not limited to, the depositary, custodian, auditor and lawyers to the extent that these are not included in transaction costs.

#### **Transaction Costs**

Costs and charges incurred for purchasing and selling securities within the fund. These costs have been calculated using the 'slippage cost' methodology. The slippage cost methodology calculates transaction costs as the difference between the price at which a transaction was executed (including charges, commissions, taxes, and other payments associated with the transaction) and the price when the order to transact was transmitted to a third-party ('arrival price'). Following a revision of the EU PRIIPs slippage cost methodology, effective January 1st, 2023, transaction costs can no longer be reported as negative value and at a minimum must be equal to but not less than the explicit costs (charges, commissions, taxes, and other payments associated with the transaction) of the fund.

#### **Incidental costs**

These include performance fees paid if certain performance levels are achieved (over and above any levels set out in the investment objective) within a set time period.
