Baillie Gifford Worldwide Islamic Global Equities Fund ("the Fund") is a sub-fund of Baillie Gifford Worldwide Funds PLC (the Company). The Fund is managed by Baillie Gifford Investment Management (Europe) Limited.

# Objectives and investment policy

• The Fund aims to provide capital growth over the long term through investing primarily in shares of companies which meet Sharia principles as interpreted and laid down by the Sharia Supervisory Board and the relevant environmental, social and governance criteria.

#### Policy

- The Fund will invest at least 90% in shares of companies globally whilst excluding companies which are inconsistent with Sharia or the United Nations Global Compact Principles for Business.
- The Fund will comply with the Investment Managers policy on assessing breaches of the United Nations Global Compact Principles for Business.
- The Fund will also not invest in companies which derive more than 30% of their total revenue from the production or distribution of thermal coal.
- The Fund will be concentrated.

• The Fund is actively managed and no index is used for the purposes of constraining the composition of the Fund's portfolio. The Fund's performance (after deduction of costs) is measured against the Dow Jones Islamic Market World Index. The Fund seeks to outperform the index.


