What does it do?

Anthropic builds frontier AI systems that companies can trust and control. Their flagship product, Claude, goes beyond typical AI chatbots by explaining its reasoning and maintaining consistent, reliable outputs. This transparency is crucial for enterprise customers in regulated industries like financial services and life sciences, where understanding AI decision-making is necessary.

Their breakthrough coding product, Claude Code, demonstrates this reliability in action, now writing 90% of code for certain Anthropic products and enabling developers to delegate entire coding tasks to AI agents. Coding represents both a critical bottleneck in the digital economy and an area where AI quality is easily measurable. This success positions Anthropic to expand into other industries with similar confidence.

Why do we invest?

At the time of investment, we had tracked Anthropic for two years, watching them evolve from a research lab to a leading AI company. While the competitive field for AI model dominance spreads out, we see increasing differentiation between Anthropic's products and their competitors—both in performance and end-use applications.

As an early leader in the enterprise applications of AI models, we believe Anthropic has the potential to become a generational company that redefines knowledge work.

Who is key?

Siblings Dario and Daniela Amodei founded Anthropic with a clear mission to address concerns around AI safety and alignment. This purpose-driven approach has helped the company attract and retain top talent. The company boasts remarkably low staff turnover even as competitors are offering outsized compensation for AI expertise.
