Commentary 04

Market Background

Markets spent much of the quarter preoccupied with political events in the United States (US) and geopolitics, especially in the Middle East. While bond, currency and commodity markets now suggest that the '12-Day War' is over, that may prove premature. We can't predict how the conflict will evolve, but we can consider what some of its broader implications might be for Emerging Markets.

In practice, the Fund's direct exposure to the Middle East is limited due to a lack of compelling bottom-up opportunities. Still, geopolitical uncertainty rarely helps the global growth outlook. In such times, two things matter most: diversification and resilience. Encouragingly, the Fund tilts toward businesses that are larger, more profitable, and more cash-generative than the benchmark and therefore have greater capacity to withstand shocks.

Energy markets may be the area where the conflict leaves a mark. On the supply side, oil exploration remains at multi-decade lows, while the Strait of Hormuz (a chokepoint for nearly a fifth of global oil supply) has re-emerged as a risk factor. Here, the Fund's overweight to the energy sector offers both upside potential and a degree of protection in the event of supply disruptions. Moreover, sustained high energy prices could accelerate the energy transition. From copper to lithium, many of the key inputs for decarbonization are produced by companies in Emerging Markets.

At the same time, the world is trying to adjust to the new United States trade order, but there are only two countries - China and the UK - that have struck some provisional tariff deal with the United States, at the time of writing. With the 90-day pause expiring in a number of days, we are not letting short-term noise dictate our decision-making, and we are sticking to our long-term, tried and tested approach. Decades of experience have taught us that this is the path to long-term returns, even if short-term newsflow dominates share price swings in the near term.

Beyond the United States-China trade talks, it's clear that we should focus much more on the forces driving the majority of fund revenue that originates elsewhere. The team has travelled east intensively this year — China, India, South Korea, Taiwan, Indonesia, Vietnam and South Africa - supplementing desk research with face-to-face conversations and, crucially, with first-hand, on-the-ground experience of the local products and services.

In Korea, the market experienced a sharp 'Value-Up' rally during the quarter. Feedback from our visit on the progress of this program was mixed, yet the recent election outcome marked a renewed momentum for corporate reform. Whilst this is a positive backdrop, it is debatable whether the greatest beneficiaries will be laggards or the quality companies we prefer.

Performance

The MSCI Emerging Markets Index delivered positive returns this quarter, and the Fund marginally outperformed. The top contributors shared a common thread: robust operating results and exposure to structural growth themes, particularly in semiconductors and e-commerce. At the country level, the underweight in Saudi Arabia proved helpful as the market lagged the broader index. Conversely, a modest underweight to South Korea (one of the stronger performing markets in the universe) and mixed stock selection in the region detracted.

MercadoLibre, also a top contributor in Quarter 1 (Q1), continued its strong run. The pan-Latin-American ecommerce and financial technology company reported strong Q1 results, with 37% year-on-year revenue growth and 44% net income growth. In Argentina, where many feared macro volatility would overwhelm consumer demand, the company achieved triple-digit growth in Gross Merchandise Value.

World-leading semiconductor manufacturer TSMC was another positive contributor, supported by resilient demand for advanced semiconductors. Despite United States (US) tariff uncertainties, the company reiterated its mid-40% long-term artificial intelligence (Al) revenue Compound Annual Growth

Rate (CAGR) and kept capital expenditure (capex) steady. Margins were also stable at nearly 59%, and pricing power on leading-edge nodes has helped absorb foreign exchange volatility and overseas expansion costs.

Some holdings were less immune to macro challenges. Brazilian energy company, Petrobras, detracted as oil price volatility dominated the quarter, with swings driven by shifting narratives around global recession and geopolitical risk. The company's Q1 results missed expectations, with revenues down 11% year-on-year and margins pressured by higher lifting costs and weaker refining markets. A more cautious stance on dividends and rising net debt has also added to investor unease. We are willing to look through the near-term headwinds from weaker oil prices and political uncertainty, as Petrobras remains a strategically important producer with long-term potential.

SQM also detracted from performance. Lithium prices continued to decline amid global oversupply, weighing on sentiment. While volumes remained strong, profitability was squeezed and earnings disappointed. The Fund's holding reflects a longer-term view of demand-supply, in which SQM's outlook is underpinned by its structural dominance in lithium and iodine, strategic expansion into key growth markets and a resilient financial profile.

Notable Transactions

There were two new purchases during the quarter.

We participated in the CATL Hong Kong initial public offering. CATL is a Chinese manufacturer of lithiumion battery cells with a dominant market share, which is poised to grow through electric vehicle (EV) uptake and energy storage. We had past concerns about valuation relative to slowing EV demand growth in China, but have been impressed by the company's ability to maintain margins and returns on capital over the last two years.

The Fund has taken a holding in Pony.ai, one of China's leading developers of autonomous driving technology. There is now a clear regulatory framework and liability regime with the government, enabling the roll-out of commercial robotaxi services in China and Pony.ai stands out amongst its competitors in the quality of its partnerships, as well as the permissions it has received from regulators to run commercial robotaxi services in major Tier 1 cities in China.

There were no complete sales during the quarter.

Stewardship

During the quarter, we met with Samsung Electronics and other companies in Korea to gain a deeper understanding of corporate governance changes taking place.

Looking at Samsung specifically, we held meetings with representatives to learn how the task force and corporate strategy offices are operating alongside current leadership and board changes. Six out of nine directors are now independent, and there has been an independent chair since 2020. In 2024 and 2025, more semiconductor expertise was brought to the board. Samsung Electronics appointed Dr. Jun Young-Hyun as co-chief executive officer (CEO) in November 2024, and he now oversees both the memory business and the Samsung Advanced Institute of Technology. We remain particularly interested in how the new CEO will lead and what strategic changes he might implement, particularly in balancing long-term objectives with the short-term focus that some observers have expressed concern about.

The trip provided a valuable opportunity to deepen our understanding of the recent governance reforms in Korea and the changes taking place in Samsung.

Market Outlook

As we look ahead, the case for the Emerging Markets asset class continues to strengthen. Our universe is increasingly driven by domestic demand, structural innovation, and businesses with global relevance, not just by shifts in risk appetite. Currency pressures appear to be easing in many countries amidst a weaker United States dollar environment, and Emerging Market companies remain central to themes like digital access and Al infrastructure. Crucially, many of the businesses we own are gaining

share, reinvesting cash flows, and growing through the current geopolitical uncertainty. That's the kind of growth we want to own on behalf of the Fund's investors and the kind we believe the market is starting to reward again. Transactions from 01 April 2025 to 30 June 2025

New purchases

Stock name	Transaction rationale
CATL	CATL is a Chinese manufacturer of lithium-ion battery cells with a dominant market share both in cathode chemistries (LFP) and form factors (prismatic), which are poised to grow through electric vehicle uptake and energy storage. The company is a national champion in China, which is the world's largest EV and electricity generation market, and it is well aligned with the state's decarbonisation objectives and emphasis on Chinese self-sufficiency in the hard sciences and technology. Beyond its home market, CATL's future growth could be further fuelled by its operations in Europe, where it already has a manufacturing presence and North America, where it currently commands a 15% market share. We like the magnitude and duration of the growth opportunity combined with CATL's market leadership, which we believe can prove defensible thanks to the company's partnerships with traditional automakers (e.g. Volkswagen and Ford) who are making the shift to electric vehicles and relying on CATL's cell-to-pack battery technology to do so.
	We had past concerns about valuation relative to slowing EV demand growth in China, but have been impressed by the company's ability to maintain margins and returns on capital over the past two years. Despite an oversupply in the battery industry overall in China, CATL was able to maintain both utilisation and pricing. This validated the value of its technology lead in terms of energy density and range, relationship with customers, and premium OEMs were willing to pay for safety and quality.
	We took advantage of its Hong Kong IPO to take a holding for the Fund.
Pony Al	We have taken a new holding in Pony.ai, one of China's leading autonomous driving companies. Operational progress by autonomous driving companies has been impressive, and more recently, Chinese operators have demonstrated attractive unit economics for robotaxis. They have also agreed a clear regulatory framework and liability regime with the government, enabling the roll-out of commercial robotaxi services in the country. Despite these technology and regulatory hurdles being overcome, market valuations have remained cautious, e.g. with Pony AI trading at half of its pre-IPO valuation. This caution appears to stem from shorter-term uncertainty and broader geopolitical issues, and so undervalues the potential of the company itself. Pony AI stands out amongst its competitors in the quality of its partnerships, which include Toyota and Tencent, as well as the permissions it has received from regulators to run commercial robotaxi services in major Tier 1 cities in China. While we expect volatility and a rapidly evolving competitive landscape, we still believe that the skew of returns here is attractive and justifies taking a small initial holding.
