

## 2025 Estimated Capital Gain Distributions

The amounts shown below are estimates of potential capital gain distributions for Baillie Gifford Funds. The estimates are based on information as of October 31, 2025 and are subject to change prior to each Fund's actual distribution.

It is possible that significant adjustments could be made to these estimates prior to the Ex-Dividend Date as shown in the table below.

The estimates do not include ordinary income distributions, other than Short-Term Capital Gains, a Fund may be making. Several Funds will also be making ordinary income distributions, but we are not

providing estimates of those at this time.

If you are a shareholder in any of the Funds listed below as of the Record Date, we expect you will receive a distribution. Actual distributions will be confirmed to shareholders and financial professionals in January 2026.

Each Fund's Short-Term and Long-Term Capital Gains rates per share are the same for all share classes within that Fund.
